### License Grant

CoDyPower LLC grants You a license to use one copy of the Software on any one hardware product only for Your internal operations.

"The Software" means the enclosed software program (the "QFTCT" or "QFT Control Toolbox") as updated, replaced or modified, and authorized for Your use by CoDyPower LLC.

"You" means the company, entity or individual whose funds are used to pay the license fee.

"Use" means storing, loading, installing, executing or displaying the Software.

You may not modify the Software, disable any licensing or control features of the Software.

There are three type of licenses available: (A) Standard, (B) Education-individual and (C) Education-concurrent. They allow installation on Windows platforms. The licenses A and C are concurrent, allowing the use of many users simultaneously. The license B is individual, which means that it may only be activated and used on a single designated computer, provided the toolbox is operated from that computer'console by one licensed user at any given time. All the licenses include the professional / full version of the toolbox. They are:

(A) QFTCT Standard license –Concurrent, perpetual. For use at a commercial, industrial, government or other organization. It can be use simultaneously by all the computers that share the same specific Matlab concurrent license of the customer network. This license allows the customer to use the purchased toolbox indefinitely.

(B) QFTCT Education-individual license –Individual, perpetual. (\*). For students at universities. For one designated computer. This license allows the customer to use the purchased toolbox indefinitely.

(C) QFTCT Education-concurrent license –Concurrent, perpetual. (\*). For students at universities. It can be use simultaneously by all the computers that share the same specific Matlab concurrent license of the classroom/lab network. It allows the customers to use the purchased toolbox indefinitely.

(\*) CoDyPower reserves the right to refuse sell the B and C licenses to anyone who does not prove an active position as student with an academic institution.

The QFTCT Education licenses (B and C) are further restricted to use in connection with on-campus computing facilities that are solely in support of classroom instruction and research activities of students. The right to use the software for commercial purposes is expressly excluded.

The documentation provided for use in connection with the Software may be printed and or copied as reasonably required only for internal use by You directly related to Your operational use of the Software. Printing and/or copying for training purposes requires the prior written authorization from CoDyPower LLC.

## **Ownership**

The Software and the documentation are owned and copyrighted by CoDyPower LLC. Your license confers no title or other ownership interest in the Software or the documentation and may not be construed as a sale of any right in the Software or the documentation. Except as expressly stated, this license does not grant You any rights to patents, copyrights, trade secrets, trademarks or any other rights, related to the Software and the documentation.

## **Copies and Adaptations**

You may only make copies or adaptations of the Software for archival purposes, when copying or adaptation is an essential step in Your authorized use of the Software.
